We have successfully registered **Singapore Council of Women's Organisations** ("SCWO"), with UEN No.: S80SS0026C, as an Institution of Public Character ("IPC").

Following this successful registration of **SCWO** as an IPC, we intend to deregister the IPC status of **SCWO - Star Shelter ("Star Shelter")** (UEN No.: T00CC1406K) and **SCWO - Service Fund ("Service Fund")** (UEN No.: T09CC0010H).
